

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Balram Das, Additional Civil Judge (Senior Division)/ ACJM, Ayodhya regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2016-18 (2016-17 & 2017-18)**, his gross income from salary is Rs.8,86,472/- and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Insurances, NSC and repayment & down-payment of car loan are Rs.6,35,930/-. The balance of Rs.1,42,373/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.2,50,542/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2016-18 (16.01.2017 to 31.03.2017 and 01.04.2017 to 31.03.2018).

It is pertinent to mention here that officer's wife ( Registrar in Stamped and Registration Department) having annual income was Rs.6,89,998/- for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining in to U.P. Judicial Service online against case id-P00001832020 (old case id- 769), which had already been seen by Hon'ble Mr. Justice Rahul Chaturvedi, the then Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide online dated 14.12.2021. As such, there is day delay in submitting the same. In this regard: officer verbatim "my unconditional apology for not submitting property statement at the time of Joining, I have not done this deliberately, It was happened due to ignorance because of I was new entered into judicial service. I shall be vigilant in future in this regard. Your Honor Please enough to condone the delay in submitting property statement."

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Balram Das, Additional Civil Judge (Senior Division)/ ACJM, Ayodhya be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders?
