May kindly see the property statement online received from Sri Ram Kishor-III, A.D.J. (POCSO), Mathura regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

***In the financial years 2018-20 (2018-19 & 2019-20)***, his gross income from salary is Rs.41,50,782/- and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Mutual Funds and Insurances are Rs.26,23,875/-. The balance of Rs.9,365/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,36,272/- (Rs.15,26,907/- from salary and Rs.9,365/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-18 online against case id:P00002682019 (old case id:381), which had already been seen by Hon'ble Mr. Justice Saumitra Dayal Singh, the then Administrative Judge Mathura Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 15.12.2021. As such, there is delay in submitting the same. In this regard officer's verbatim: "ससम्मान अवगत करना है कि पूर्व में मेरे द्वारा जो प्रोपर्टी स्टेटमेन्ट भेजे गये थे उसमें लिपिकीय त्रुटि के कारण वर्ष 2018 से 2020 वित्तीय वर्ष के स्थान पर 2019-2021 हो गया था जिसको मेरे द्वारा दुरुस्त करते हुए पुनः प्रोपर्टी स्टेटमेन्ट वित्तीय वर्ष 2018-2020 का भेजा जा रहा है। अतः महोदय से विनम्र निवेदन है कि मेरे प्रोपर्टी स्टेटमेन्ट को स्वीकार करते हुए विलम्ब को क्षमा करने की कृपा करें."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ram Kishor-III, A.D.J. (POCSO), Mathura be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
