May kindly see the property statement online received from Smt. Reeta Gupta, Principal Judge, Family Court, Gonda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2016-18 (2016-17 & 2017-18), her gross income from salary is Rs.38,16,557/- and total deductions/Savings/investments GPF, GIS, Income Tax, FDR, PPF and Insurance is Rs.37,59,432/-. The balance of Rs.10,53,284/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,10,409/- (Rs.57,125/- from salary and Rs.10,53,284/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2016-18 (2016-17 & 2017-18).

It is pertinent mention here that's Officer's Husband (A.D.J.) having annual income was Rs.16,44,288/- for the financial year 2016-17 & Rs.16,98,723/- for the financial year 2017-18 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2014-16 (2014-15 & 2015-16) online against case id- P00046302021 (Old Case Id :6787) and same has been processed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide online dated 13.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer has stated that excess of judicial work, inadvertently she had not submitted property-statement on time. Officer has apologized for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Smt. Reeta Gupta, Principal Judge, Family Court, Gonda be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders?
