In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.41,26,262/-and total deductions/savings/repayment/investment against GPF, GIS, Income Tax and the balance of his savings bank account(s) is also enhanced by Rs.4,37,151/- in this financial year from previous year's balance, total of which is Rs.14,92,175/-. Thus, a sum of Rs.26,34,087/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. It is pertinent to mention here that officer's wife is working as advocate and her monthly income is Rs.45,000/- in both the financial year, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2018-20 and the same has also been processed online against Case Id: P00046592021 before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) firstly vide online dated 15.12.21 which was before time and was not properly filled. Accordingly, objection was raised to submit proper details and after that officer has submitted the properly filled statement of the financial year 2020-22 vide online dated 18.03.2024 in attachment. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Arvind Kumar-II, Presiding Officer, Motor Accident Claims Tribunal, Lalitpur, be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
