May kindly see the property statement online received from Smt. Poornima Pathak, Additional District & Sessions Judge, Kannauj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross income from salary is Rs.40,11,338/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, Home loan, PPF a/c and amount paid against Home purchase (margin money) are Rs.35,41,831/-. Thus, a sum of Rs.4,69,507/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.2,71,302/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Tehsildar (Alld PCS) having monthly income of Rs.78,464/-.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial year 2010-11 which had already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Raebareli, placed in the misc. file of the officer. And property statement of the financial year 2011-12 to 2017-19 has been seen by Hon'ble Mr. Justice Karunesh Singh Pawar, the then Administrative Judge, Sitapur Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial year 2019-21 vide online dated 14.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-20 & 2020-21 of Smt. Poornima Pathak, Additional District & Sessions Judge, Kannauj be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
