May kindly see the online property statements received from Sri Pawan Kumar Rai, Additional District & Sessions Judge (F.T.C.), Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, total Gross salary is Rs.29,39,399/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF a/c, LIC policies, SIPs, Home Renovation loan EMI and Home loan are Rs.23,16,498/-. Thus, a sum of Rs.6,22,901/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,39,243/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is a lawyer having annual income of Rs.4.23 lacs and Rs.6.59 lacs in the financial years 2018-19 & 2019-20 respectively. His father is also a pensioner having annual pension of Rs.10.22 lacs and Rs.10.64 lacs in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2011-12, which has already been seen offline by Hon'ble Mr. Justice S.N.Shukla, the then Administrative Judge, Mirzapur, placed in the misc. file of the officer. Property statements of the financial years 2012-13 & 2013-14, 2014-15 & 2015-16 and 2016-17 & 2017-18 have been processed on e-Service IDs 4730, 6656 and 6840 respectively and detailed office notes have been submitted on the same.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 firstly vide online dated 15.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "The Undersigned is extremely sorry for the delay in submission of property statement due to health reasons of his old parents who are about 70 years mother of undersigned has been suffering from chronic lungs disease (COPD) and is dependent on domiciliary oxygen and non invasive ventilator since 2013, As a matter of fact she has been admitted to ICU at Laxmi Hospital Varanasi on 06/12/2021, though she recovered and is out of ICU on 10/12/2021, but she is still on oxygen support and fighting for her life. Father of undersigned has also been suffering from psoriasis bone disease and acute depression since 2014, brother of applicant stays far away in Bangalore and the undersigned is the only member in the family to look after aged and ailing parents, undersigned further assures to be careful and punctual in future", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Pawan Kumar Rai, Additional District & Sessions Judge (F.T.C.), Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
