He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 17.12.2021. As such, there is delay in submitting the same. In this regard, officer is seeking unconditional apology for not submitting statement on time, officer shall be vigilant in future in this regard.
