May kindly see the property statement received online from Smt. Kavita Singh, Chief Judicial Magistrate, Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2013-2015 (2013-14 & 2014-15) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2013-2015 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2013-2015 (2013-14 & 2014-15), the Gross income from salary is Rs.12,19,044/- and total deductions/ repayment/ savings/ investment against GIS, PPF, Insurances and Income Tax are Rs.2,00,393/- and the balance of her savings bank account is also increased by Rs.75,869/- in this financial year from previous year's balance, total of which is Rs.2,76,267/-. Thus, a sum of Rs.9,42,782/- was therefore available with her to meet out the household expenditure of her family consisting of six members in the financial year 2013-2015 (2013-14 & 2014-15).

It is pertinent to mention here that her father, Pensioner, have annual income of Rs.3,47,288/- in both financial years.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements at the time of joining online against Case Id :P00045542021 (Old Case Id : 6711) and the same has been processed before before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushi Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2013-2015 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. She has firstly submitted movable and immovable property statements of the financial year 2013-2015 (2013-14 & 2014-15) vide online dated 15.12.2021. As such, there is delay in submitting the same. In this regard, the officer has stated in her online reply dated 14.09.2023, that (in her verbatim) "उत्तर प्रदेश सरकार द्वारा जारी की गई दि. 15.12.2021 के आदेश के अनुसार, मैंने 2013-15 के लिए अपनी संपत्ति विवरण ऑनलाइन पर 15.12.2021 को जमा कराया था। मैंने 14.09.2023 को ऑनलाइन जवाब दिया कि मैंने 15.12.2021 को ही संपत्ति विवरण जमा किया था।"

May, therefore, if approved, property statements for the financial year 2013-2015 (2013-14 & 2014-15) of Smt. Kavita Singh, Chief Judicial Magistrate, Kushi Nagar at Padrauna, be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushi Nagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
