May kindly see the property statement online received from Sri Arvind Rai, Additional District & Sessions Judge, Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary and other sources is Rs.78,68,892/- (Rs.51,48,892/- from salary, Rs. 26,00,000/- gift given by father and Rs. 1,20,000/- from House Rent) and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Insurances , Repayment of housing loan, FD, and the balance of his savings bank account(s) is also enhanced by Rs.2,32,665/- in this financial year from previous year's balance, total of which is Rs.61,44,516/-. Thus, a sum of Rs.17,64,516/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2017-18 online against case id: P00000072020 (Old case id-507), which has been seen by Hon'ble Mr. Justice Rajnish Kumar, the then, Administrative Judge, Deoria.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 14.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that due to the nationwide lock down and closure of District Courts because of the COVID-19 pandemic, He is hereby annexing the same for your kind information and needful. The above information is being sent on the prescribed proforma. It is, therefore, most humbly requested to you to please, by pardoning the application in late forwarding this application, bring this information to the knowledge of the Honorable High Court, for the above, he shall always be thankful and ever be grateful.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Arvind Rai, Additional District & Sessions Judge, Shahjahanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur for His Lordship's kind perusal and orders?
