Thus, a sum of Rs.15,65,594/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that her husband have income Rs.5,00,000/- per annum through Advocacy.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held upto the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id : P00047252021 (Old Case Id: 6883) and the same has been processed before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 15.12.2021. As such, there is no delay in submitting the same.
