May kindly see the property statement online received from Sri Lokesh Rai, Presiding Officer, Motoar Accident Claims Tribunal, Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court. In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary is Rs.45,55,589/- and total deductions/Savings/investments against NPS, GIS, Income Tax, Insurances, PPF, Sukanya Samriddhi Yojna, and Repayment of car loan are Rs.29,46,791/-. The balance of Rs.26,539/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.16,35,337/- (Rs.16,08,798/- from salary and Rs.26,539/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2017-19 (2017-18 & 2018-19) against online case id-P00009152020 (old case id-1800), which had already been seen Hon'ble Mr. Justice Om Prakash-VII, the then Administrative Judge, Varanasi Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 14.12.2021. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Lokesh Rai, Presiding Officer, Motoar Accident Claims Tribunal, Lakhimpur Kheri be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
