May kindly see the property statement received online from Sri Kuwar Mitresh Singh Kushwaha, Civil Judge (Senior Div.), Mau, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2015-17 (2015-16 & 2016-17), the Gross income from salary is Rs.14,08,939/- and total deductions/savings/investment against GIS, PPF, Insurences and Income Tax is Rs.5,18,637/- and the balance of his savings bank account(s) is also increased by Rs.4,49,417/- in this financial year from previous year's balance, total of which is Rs.9,68,054/-. Thus, a sum of Rs.4,40,885/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining online against Case Id: P00007692020 (old case id: 1609) and the same has been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-17 (2015-16 & 2016-17) vide online dated 20.12.2021. As such, there is delay in submitting the same for which the officer stated that (in his verbatim) "due to some medical problem of my mother I could not submit my property statement in time. My mother was suffering from lukemia and my self from Uvitis, (Eye Problem) due to this I could not submit property statement in time. I shall not repeat this mistake in future."

May, therefore, if approved, property statements for the financial year 2015-17 (2015-16 & 2016-17) of Sri Kuwar Mitresh Singh Kushwaha, Civil Judge (Senior Div.), Mau, be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
