May kindly see the property statement online received from Smt. Sangeeta-I, Additional Chief Judicial Magistrate, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2015-17 (2015-16 & 2016-17), her gross income from salary is Rs.16,81,056/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of Car loan and Insurance is Rs.5,67,076/-. The balance of Rs.50,956/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,13,980/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2015-17 (2015-16 & 2016-17).

It is pertinent mention here that's Officer's Husband (Teacher in Private Institution) having annual income was Rs.1,80,000/- for the financial years 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of joining into U.P. Judicial Service online against case id-P00005132023 and same has been processed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. She has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide dated 18.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "The delay in filling the property statement was due to Covid-19 Pandemic. After that due to lots of court work, details needed to fill in the property statement could not be collected on time."

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Smt. Sangeeta-I, Additional Chief Judicial Magistrate, Ramabai Nagar be laid before Hon'ble Mr. Justice Rajnish Kumar , Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
