May kindly see the property statement submitted online received from Sri Rahul Kumar Singh, Chief Judicial Magistrate, Baghpat, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-19 (2017-18 & 2018-19), income from salary is Rs.25,11,737/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC policies, PPF a/c, Car loan and the balance of his savings bank account(s) is enhanced for Rs.3,87,289/- this financial year from previous year's balance, total of which is Rs.13,54,237/-. Thus, a sum of Rs.11,57,500/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

In this connection, it is submitted that Sri Rahul Kumar Singh has already submitted his property statement upto the financial year 2015-17 which has already been processed on old case ID no.-6939 before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 15.12.2021. As such, there is delay in submitting the same from the part of the officer, for which he stated that the delay occurred due to much work pressure and some personal problems related to medical and family, for which he apologizes and ensure that he will not repeat this mistake in future.

May, therefore, if approved, property statements of the financial years 2017-19 (2017-18 & 2018-19) of Sri Rahul Kumar Singh, Chief Judicial Magistrate, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
