May kindly see the property statement received online from Sri Gaurav Kumar, Additional District & Sessions Judge, Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), his total income (from salary Rs. 51,58,525 from house property Rs. 2,32,028) is Rs.53,90,553/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, Sukanya samridhi, insurance policies and the balance of his savings bank account is also enhanced by Rs.7,16,384/- in this financial year from previous year's balance, total of which is Rs.29,01,738/-. Thus, a sum of Rs.24,88,815/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statement upto the the financial year 2016-18 and the same has been approved online against Case Id: P00002762020 by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted his movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 17.12.21. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated that 'due to frequent transfer and corona pandemic he could not furnish the property statement for the financial year 2018-20 in time. The applicant is highly apologetic and prays that in future the statement will be furnished well within time', as mentioned in his attachment letter dated 17.12.2021.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Gaurav Kumar, Additional District & Sessions Judge, Rampur be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
