May kindly see the property statement received online from Sri Mohd. Sajid-I, Addl. Civil Judge (Sr.Div.)/ACJM. Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary is Rs. 18,99,578/- and total deductions/savings/ investment against NPS, PPF, NSC, GIS, Income Tax, Insurances, Car loan repayment is 8,52,542/- and the balance of his savings bank account(s) is also reduced by Rs.8,05,322/- in this financial year from previous year's balance. Thus, a sum of Rs. 18,52,358/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-20 (2018-19 & 2019-20) .

It is also pertinent to mention here that his wife earned Rs.10,000/- approx. in the financial years 2018-19 respectively from her own business along with her son.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18 (2016-17 & 2017-18) online against Case Id : P00000532020 (Old Case Id :598), which has already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Barabanki.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 18.12.2021. As such, there is delay in submitting the same. In this regard, officer has given reason of delay (in his verbatim), as under:

"Most respectfully I apologise unconditionally for the delayed submission. Kindly pardon me for the delay caused. I shall not repeat the same in future and from now on, I will submit my next property statements in time."

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Mohd. Sajid-I, Addl. Civil Judge (Sr.Div.)/ACJM. Agra, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra, for His Lordship's kind perusal and orders?
