May kindly see the property statement online received from Sri Hari Ram, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-14 & 2014-15 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-14 & 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2013-14 & 2014-15, Total Gross income from salary & allowances are Rs.16,41,569/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, NSC, Car loan and the balance of his savings bank account(s) is enhanced for Rs.1,77,394/- this financial year from previous year's balance, total of which is Rs.6,32,584/-. Thus, a sum of Rs.10,08,985/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Amar Saran, the then Administrative Judge, Fatehpur, placed in the misc. file of the officer and for the financial years 2009-10 & 2010-11 and 2011-12 & 2012-13 which had been processed on e-service IDs 6964 and 6965 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-14 & 2014-15 in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 vide online dated 16.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated in his attachment letter that *"he was not able to collect all the relevant documents relating to his property statement on time due to bonafide mistake and Covid 19 pandemic. He assure that this will not happen again in near future. He therefore requested to look forward for kind consideration and kindness to accept his apology."*

May, therefore, if approved, property statements of the financial years 2013-14 & 2014-15 of Sri Hari Ram, Additional District & Sessions Judge, Meerut be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
