May kindly see the property statement received online from Smt. Suneeta Sharma, Addl. Principal Judge, Family Court, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.33,37,033/- (Rs.31,45,643/- from salary and Rs.1,91,390/- from PPF) and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, PPF, Mutual Fund, SIP, Sukanya Samriddhi Yojna, Loan Repayment and Insurances are Rs.24,40,722/- and the balance of her savings bank account is also increased by Rs.1,21,746/- in this financial year from previous year's balance, total of which is Rs.25,62,468/-. Thus, a sum of Rs.7,74,565/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held upto the financial year 2017-19 (2017-18 & 2018-19) online against Case Id : P00001662020 (old case id : 749) and the same has been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Hamirpur, Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 17.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Suneeta Sharma, Addl. Principal Judge, Family Court, Bareilly, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
