

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Rakhi Dixit, Addl. Principal Judge, Family Court, Bulandshahar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2014-2016 (2014-15 & 2015-16)**, the Gross income from salary including allowances is Rs.23,22,453/- and total deductions/savings/investment against NPS, GIS, PPF, PLI and Income Tax is Rs.9,64,510/- and the balance of her savings bank account(s) is also increased by Rs.71,265/- in this financial year from previous year's balance, total of which is Rs.10,35,775/-. Thus, a sum of Rs.12,86,678/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2014-2016 (2014-15 & 2015-16).

It is pertinent to mention here that her husband is a Judicial Officer having annual income of Rs.15,04,399/- & 16,82,914/- from salary and Rs.50,000/- & Rs.1,50,000/- from agriculture in the F.Y. 2014-15 & 2015-16 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial year 2012-2014 (2012-13 & 2013-14) online against Case Id : P00048242021 (Old Case Id : 6984) and the same has been processed before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. She has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 17.12.2021. As such, there is delay in submitting the same for which the officer has stated in the attachment dated 15.12.2021, that the movable and immovable property statement could not be sent within the prescribed time due to excess of judicial work and non-receipt of related details and the officer would always be alert to such mistakes in future.

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Smt. Rakhi Dixit, Addl. Principal Judge, Family Court, Bulandshahar, be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders?
