May kindly see the online property statements received from Sri Vishnu Deo Singh, Additional District & Sessions Judge, Kaushambi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income is Rs.44,36,871/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, NPS arrear, PPF, Income Tax, Insurance policies, Sukanya Samriddhi Yojna and the balance of his savings bank account(s) has been enhanced for Rs.6,55,718/- this financial year from previous year's balance, total of which is Rs.22,21,034/-. Thus, a sum of Rs.22,15,837/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2014-15 which had already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur, placed in the misc. file of the officer. And a detailed offline note has been laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders, for the (offline) property statements of the financial years 2015-17. A detailed online note has been laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders, for the online property statements of the financial years 2017-19 on eService ID P00048412021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 18.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 of Sri Vishnu Deo Singh, Additional District & Sessions Judge, Kaushambi be laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
