In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.69,11,258/- (Gross income from salary with allownces is Rs.49,15,120/- , Interest from Bank account,FDR, PPF, NSC is Rs.8,75,438/- and FD matured for Rs.11,20,700/- and total deductions/ repayment/ savings/ investment against CPF, GIS, TDS, PPF, SBI Insurance Policy, Bajaj Insurance Policy, FDR is Rs.50,09,436/-. Thus, a sum of Rs.19,01,822/- was available with her to meet out the household expenditure of her family consisting of four members in both of the financial years and the balance of her savings bank account(s) is decreased by Rs.1,19,065/- this financial year from previous year's balance

It is pertinent to mention here that her husband is working as an Advocate having income Rs.8,74,380/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2016-18 against Case id-P00001382020 online and same has been approved with remark not to delay submission in future by the Hon'ble Mr. Justice Pankaj Bhatia, the then, Administrative Judge, Etah Judgeship

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 15.12.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason but she is requesting to condone the delay in filling the property statement.
