May kindly see the property statement online received from Sri Arvind Verma, Additional Chief Judicial Magistrate, Amroha regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income is Rs.27,68,604/- (income from salary is Rs.26,70,667/- and matured amount of NSC of Rs.97,937/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Insurance policies, PPF, RD and the balance of his savings bank account(s) is enhanced for Rs.3,91,348/- this financial year from previous year's balance, total of which is Rs.12,77,519/-. Thus, a sum of Rs.14,91,085/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife is Practicing Advocate/ Consultant having approx. income of Rs.2,95,800/- & Rs.2,96,900/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Imtiyaz Murtaza, the then Administrative Judge, Ramabai Nagar, in the misc. file of the officer and for the financial years 2009-10 & 2010-11, 2011-12 & 2012-13, 2013-14 & 2014-15 and 2015-16 & 2016-17 which had been processed on Case ID nos. P00000072019, P00048702021, P00048712021 and P00048732021 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 16.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not submitted the aforesaid property statements due to busy in excessive Judicial work as a new entrant in the service and participate in training in I.J.T.R., for which he has regretted" mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Arvind Verma, Additional Chief Judicial Magistrate, Amroha be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
