May kindly see the property statements online received from Sri Arvind Verma, Additional District & Sessions Judge (F.T.C.), Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income is Rs.31,24,731/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, Insurance policies, Income Tax, Insurance policies, RD and the balance of his savings bank account(s) is enhanced for Rs.22,592/- this financial year from previous year's balance, total of which is Rs.14,35,342/-. Thus, a sum of Rs.16,89,389/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

IIt is pertinent to mention here that his wife is Practicing Advocate/ Consultant having approx. income of Rs.3,15,700/- & Rs.3,63,100/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Imtiyaz Murtaza, the then Administrative Judge, Ramabai Nagar, in the misc. file of the officer and for the financial years 2009-10 & 2010-11, 2011-12 & 2012-13, 2013-14 & 2014-15 and 2015-16 & 2016-17 which had been processed & separate detailed online notes have been laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders on Case ID nos. P00000072019, P00048702021, P00048712021, P00048732021 and P00048742021 respectively. Property statements of the financial years 2017-19 has already been seen online by Hon'ble Mr. Justice Raj Beer Singh, the then Administrative Judge, Amroha.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 16.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 of Sri Arvind Verma, Additional District & Sessions Judge (F.T.C.), Azamgarh be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders?
