May kindly see the property statement received online from Smt. Yasmin Akbar, Addl. District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.30,39,982/- and total deductions/ repayment/ savings/ investment against GIS, PRAN, PPF, Loan repayments, Gold ornaments, Term deposit, Insurances/policies and Income Tax are Rs.13,25,113/- and the balance of her savings bank account is also increased by Rs.2,10,887/- in this financial year from previous year's balance, total of which is Rs.15,36,000/-. Thus, a sum of Rs.15,03,982/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that Officer's husband Mr. Nusrat Khan is a Judicial Officer having salary almost same as the Officer.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id: P00038992021 (Old Case Id: 6047) and the same has been processed before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 22.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated that (in her verbatim) "I, humbly, seek apology for delay in sending the Property Statement", in the remark column.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Yasmin Akbar, Addl. District & Sessions Judge, Meerut, be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
