In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21 (2019-20 & 2020-21), her gross income from salary is Rs.32,08,470/- and total deductions/Savings/investments against Savings in Bank account, CPF, GIS, Income Tax (TDS), RD, PPF, Repayment of Car loan and Insurance is Rs.14,05,556/-. The balance of Rs.3,41,416/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.21,44,330/- (Rs.18,02,914/- from salary and Rs.3,41,416/- from saving bank account) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent mention here that's Officer's Husband (Teacher in Private Institution) having annual income was Rs.4,20,000/- for the financial year 2019-20 & Rs.4,80,000/- for the financial year 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2017-19 (2017-18 & 2018-19) online against case id-P00049252021 (Old Case Id :7087) and same has been processed before Hon'ble Mr. Justice Rajnish Kumar , Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide dated 18.12.2021 on eServicesJo portal. As such, there is no delay in submitting the same.
