May kindly see the property statement submitted online dated 18.12.2021 received from Sri Ateeq Uddin, Additional District and Sessions Judge, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 (financial year 2017-19) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 (financial year 2017-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2017-18 & 2018-19 (financial year 2017-19) total income from Salary is Rs.34,90,231/- and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF/NPS, NSC, GIS, Income Tax, car loan and the balance of his savings bank account(s) is also enhanced for Rs.26099/- this financial year from previous year's balance, total of which is Rs.11,98,554/-. Thus, a sum of Rs.22,91,677/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2015-17 which is also processed online and laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad for kind perusal and orders on e-service ID No.5150.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 (financial year 2017-19) in its next financial year i.e., 2019-20 upto March 2020. He has suibmitted the same vide his online letter dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which officer has stated that due to corona and mixing the papers during the transfer, papers could not be collected properly and because of work load that why he could not submit the statements in due time for that he is sorry for not sending property statement on time and further he requested that the Hon'ble court may be pleased to forgive him regarding this mistake.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 (financial year 2017-19) of Sri Ateeq Uddin, Additional District and Sessions Judge, Allahabad be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
