

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Nusrat Khan, Addl. District & Sessions Judge, Meerut, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2017-2019 (2017-18 & 2018-19)**, the Gross income is Rs.32,00,604/- (Rs.29,56,499/- from Salary including arrears and Rs.2,44,105/- from maturity of NSC) and total deductions/savings/investment against GIS, PRAN, PPF, Car Loan repayments, Gold ornaments, Insurances and Income Tax is Rs.12,72,741/- and the balance of his savings bank account(s) is also increased by Rs.3,67,013/- in this financial year from previous year's balance, total of which is Rs.16,39,754/-. Thus, a sum of Rs.15,60,850/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that Officer's wife Mrs. Yasmin Akbar is a Judicial Officer having salary almost same as the Officer.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00042962021 (Old Case Id : 6449) and the same has been processed before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 18.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer has stated that (in his verbatim) "*I, humbly, seek apology for delay in sending the Property Statement*", in the remark column.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Nusrat Khan, Addl. District & Sessions Judge, Meerut, be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
