May kindly see the online property statements received from Sri Arvind Kumar Srivastava, Principal Judge, Family Court, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-19 & 2019-20, Total income are Rs.53,35,708/- (total Gross salary are Rs.49,00,708/-, House rent of Rs.3,60,000/- and interest income of Rs.75,000/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, PPF a/cs and Mutual Fund are Rs.25,16,284/-. Thus, a sum of Rs.28,19,424/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both the financial years. And the balance of his savings bank account has also been reduced for Rs.1,25,249/- in this financial year from previous year's balance.

It is pertinent to mention here that his mother's annual pension are Rs.9,22,696/- and Rs.11.26,969/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which has already been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Rampur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has *extremely sorry for delay and inconvenience caused of Hon'ble High Court*, mentioned in the attachment "File".

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Arvind Kumar Srivastava, Principal Judge, Family Court, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
