May kindly see the property statement submitted online received from Sri Dinesh Tiwari, Special Judge (SC/ST, Pev. Of Atroci Act), Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income is Rs.48,16,347/- and total deductions/ repayment/ savings/ investment against GIS, Insurance policy, PPF, Income Tax, PRAN, PLI, FD, Mutual Fund, shares and the balance of his savings bank account(s) is enhanced for Rs.7,84,307/- this financial year from previous year's balance, total of which is Rs.34,46,617/-. Thus, a sum of Rs.13,69,730/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his wife is lecturer having monthly income of Rs.68,000/- and Rs.73,000/- per month in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Shekhar Kumar Yadav, the then Administrative Judge, Kaushambi, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "*the delay has been caused due to many unavoidable circumstances and the statements due for being submitted next year will be submitted in time without any undue delay. Seeking humble apology with folded hands for the delay*", mentioned in attachment "application letter".

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Dinesh Tiwari, Special Judge (SC/ST, Pev. Of Atroci Act), Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
