In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.37,48,372/-(Rs.34,02,906/- from Salary, Rs.36,438/- from SB account interest and Rs.3,09,028/- from maturity of RD account) and total deductions/savings/investment against GIS, NPS, PPF, various RD deposits and Income Tax is Rs.16,54,579/- and the balance of his saings bank account(s) is also increased by Rs.14,27,321/- in this financial year from previous year's balance, total of which is Rs.30,81,900/-. Thus, a sum of Rs.6,66,472/- was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that Officer's father is a farmer having annual income of Rs.60,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id : P00025952021 (Old Case Id : 4732) and the same has been processed before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 22.12.2021. As such, there is no delay in submitting the same.
