May kindly see the property statement submitted online received from Sri Ram Chandra Yadav-I, presently posted as Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary and other sources (Salary Rs. 34,74,732/-, interest from S/B A/c Rs 8378, inncome from Agriculture 66,600/-, income from rent 1,71,000/- and Personal Loan Rs. 11,00,000/-) is Rs. 48,20,710/- and total deductions/savings/investments against GPF, GIS, PPF, Income Tax, Insurances (LIC & PLI), RD, PL, House Rent, Registration amount for plot and First installment of residential plot is Rs. 34,32,942/-. Thus a sum of Rs. 13,87,768/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 98,036/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice K.J. Thaker, the then Administrative Judge, Kaushambi in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 19.12.2021. As such, there is delay in submitting the same from the part of the officer and he has stated that due to deteriorating health of his mother and high work load, he was unable to submit the statement under the deadline and sincerely apologize for the oversight.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Ram Chandra Yadav-I, presently posted as Additional District & Sessions Judge, Ghaziabad, be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
