May kindly see the property statement submitted online received from Sri Ram Chandra Yadav-I, presently posted as Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 22018-20 (2018-19 & 2019-20), his Total income from salary and other sources (Salary Rs. 44,61,505/-, interest from S/B A/c Rs 23,247, income from Agriculture 47,300/-, income from rent 3,84,000/-, income from return from LIC Rs. 77,378/- and personal loan Rs.10,00,000/-) is Rs. 59,93,430/- and total deductions/savings/investments against GPF, GIS, PPF, Income Tax, Insurances (LIC & PLI), RD, Personal loan, and the balance of his Saving bank A/c(s) is enhanced for Rs. 3,06,292/- this financial year from previous year's balance, total of which is Rs. 31,61,918/-. Thus a sum of Rs. 28,31,512/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2016-18 (2016-17 & 2017-18) which is also processed online and laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Ghaziabad for kind perusal and order on e-service Id no. 7190.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 19.12.2021. As such, there is delay in submitting the same from the part of the officer and he has submitted that due to Covid-19 pandemic, deteriorating health of his mother and high work load he was unable to submit the statement under the deadline and sincerely apologize for the oversight.
