

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Sudesh Kumari, Addl. Chief Judicial Magistrate, Sitapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

**In the financial year 2015-2017 (2015-16 & 2016-17)**, the Gross income from salary is Rs.15,39,672/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, down payment of Car and Car Loan repayment are Rs.3,06,223/- and the balance of her savings bank account is also increased by Rs.53,334/- in this financial year from previous year's balance, total of which is Rs.3,59,557/-. Thus, a sum of Rs.11,80,115/- was therefore available with herself in the financial year 2015-2017 (2015-16 & 2016-17).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements at the time of joining online against Case Id : P00049732021 (old case id : 7140) and the same has been processed before before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. She has submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 24.12.2021. As such, there is delay in submitting the same. In this regard, the officer has stated in her online reply dated 25.08.2023, that (in her verbatim) *"I again apologize for this that I could not fill the Property Statement in time as I was not aware that it is ought to be filled upto March 2018. kindly forgive my mistake,I will be thankful to you."*

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Smt. Sudesh Kumari, Addl. Chief Judicial Magistrate, Sitapur, be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
