May kindly see the property statement online received from Sri sanjay Hari Shukla, Presiding Officer, Motor Accident Claims Tribunal, Ghazipur regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2015-17 (2015-16 & 2016-17)**, his gross income from salary is Rs.31,14,427/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF and Insurances are Rs.11,07,164/-. The balance of Rs.58,732/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.20,07,263/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2013-15 (2013-14 & 2014-15) online against case id-P00050622021 (old case id-7232) and same has been processed before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide online dated 28.01.2022. As such, there is delay in submitting the same. In this regard officer has submitted reason for delay in remark column that " it is humbly submitted that I had joined the UP HJS service on 19.08.2013 and just after that went to complete my Judicial Training for three months. After returning from the training in February 2014 remained busy in completion of quantum of work. It is further submitted earlier it was not brought in my notice that property statement was to be submitted. After that I was remained busy to achieve the quantum of work and various administrative work as assigned by the superior officers time to time. In the meantime I faced many troubles as my father was died after hospitalization and my old aged mother became ill as well as my younger son got burnt badly, in these adverse situation I had to manage and spent too much time for all these family responsibilities. Due to these reasons I could not concentrate to prepare and submit the property statement for the periods of financial years 2015-17 & 2017-19 in due time for which I am tendering my unconditional apology and also undertake that no such mistake shall be committed in future. With this apology I am submitting my property statement for the financial years 2015-2017."

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Sanjay Hari Shukla, Presiding Officer, Motor Accident Claims Tribunal, Ghazipur be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders?
