May kindly see the property statement received online from Smt. Sudesh Kumari, Civil Judge (Senior Div.), Sitapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.23,41,225/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Car Loan repayment and Insurances are Rs.10,37,605/- and the balance of her savings bank account is also increased by Rs.3,28,489/- in this financial year from previous year's balance, total of which is Rs.13,66,094/-. Thus, a sum of Rs.9,75,131/- was therefore available with herself in the financial year 2017-2019 (2017-18 & 2018-19).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00050612021 (old case id : 7231) and the same has been seen by Hon'ble Mr. Justice Karunesh Singh Pawar, the then Administrative Judge, Sitapur Judgship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has firstly submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 24.12.2021. As such, there is delay in submitting the same. In this regard, the officer has stated in her online reply dated 04.09.2023, that (in her verbatim) *"in these financial years, my mother health started deteriorating, due to which I was extremely busy, in January 2018 my mother Late Smt Ratan Prabha was paralyzed in all over body, so my parents stayed at my posting place with me. But after little improvement my mother went to Bareilly in her home where she tried to walk but unfortunately she got major fractured ,my mother's hips replacement major operation was done in New Delhi. But inspite of successful operation she could not stand and my mother became bedridden, that's why my parents stayed with me continuously. My mother remained on bed till her last moment. My Lordship being busy in judicial work and day and night taking care of my mother, I could not remember to fill the property statement in time, for this mistake please kindly forgive me, I shall be highly obliged to you."*

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Sudesh Kumari, Civil Judge (Senior Div.), Sitapur, be laid before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Sitapur Judgship for His Lordship's kind perusal and orders?
