May kindly see the property statement received online from Smt. In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.30,35,109/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Car and Personal Loan repayment and Insurances are Rs.13,74,736/- and the balance of her savings bank account is also decreased by Rs.2,02,886/- in this financial year from previous year's balance. Thus, a sum of Rs.18,63,259/- (Rs.16,60,373/- from her Salary and Rs.2,02,886/- from her SB account) was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that her husband is a Businessman.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held upto the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id: P00050672021 (old case id: 7238) and the same has been processed before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 24.12.2021. As such, there is no delay in submitting the same.
