May kindly see the property statement online received from Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), his gross income from salary is Rs.25,14,742/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, Repayment of Personal Loan and Insurances are Rs.8,86,710/-. The balance of Rs.1,40,818/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.16,28,032/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2010-11 to 2015-16 offline, which had already been approved by Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship on 29.01.2024, however, by ordering ".....given last opportunity to be cautious in timely submission of property statements, failing which appropriate action will be taken". The order is placed in the Misc. file of the officer and already communicated to the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 22.12.2021. As such, there is delay in submitting the same. In this regard officer verbatim: " The mother of applicant was severely ill. The applicant is the only son in the family, therefore all the responsibilities viz. to take care of her and her medication. In addition to this, elder son of the applicant was patient of Young tied and he is diagnosed then operated. Applicant's mother has many old age problem i.e. heart problem, sugar and hypertension as well as neuro problem and she had very low visibility and is not able to move anywhere without the support of a person. Due to the aforesaid reasons, applicant was in very troubled. In this circumstances, the applicant could not file property statement in the prescribed time. With due respect, applicant assures the delay with respect to filling property statement will not occur in near future again."

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship Judgeship for His Lordship's kind perusal and orders?
