May kindly see the property statement submitted online received from Sri Devendra Singh-II, Presiding Officer, Motor Accident Claims Tribunal, Etawah regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his total income from salary and other sources is Rs. 43,41,794/- (Gross salary including allowances) and total deductions/savings/investments against GIS, NPS, Income Tax, Insurances, PPF and SIP is Rs. 21,82,033/- (including enhancement of Rs.1,35,287/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 21,59,763/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is an advocate and her annual income is Rs. 4,90,000/- approximately.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2017-19 which has already been processed online on case id no.P0000015202 before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Etawah Judgeship.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 21.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Devendra Singh-II, Presiding Officer, Motor Accident Claims Tribunal, Etawah, be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Etawah Judgeship for His Lordship's kind perusal and orders?
