May kindly see the property statement online received from Sri Dhannjay Kumar Misra, Additional District & Sessions Judge, Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2013-15 (2013-14 & 2014-15), Gross income from salary Rs. 16,00,028/- and total deductions/savings/ investment against CPF, NPS, GIS, Income Tax, PPF, repayment of car loan & personal loan and the balance of his savings bank account(s) is also increased by Rs.82,987/- in this financial year from previous year's balance, total of which is Rs.3,33,609/- . Thus, a sum of Rs.12,66,419/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

It is pertinent to mention here that his father is a pensioner having annual income Rs.1,69,000/-.

In this connection, it is submitted that the Officer has already submitted his property statements for the financial years 2011-13 (2011-12 & 2012-13) online against Case Id- P00050632021 same has been moved before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial year 2013-15 (2013-14 & 2014-15) vide online dated 23.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that's due to the pressure of judicial work, family obligations and other unavoidable circumstances, there was no intention of willful delay in sending the property statement. He apologize for the delay.
