

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sushri Zeenat Parveen, Nyayadhikari, Gram Nyayalaya, Lalganj-Mirzapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2019-2021 (2019-20 & 2020-21)**, the Gross income from salary is Rs.13,05,814/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Donation, PPF, ROA, Sump. All. and Insurances are Rs.3,28,066/- and the balance of her savings bank account is also increased by Rs.2,05,295/- in this financial year from previous year's balance, total of which is Rs.5,33,361/-. Thus, a sum of Rs.7,72,453/- was therefore available with herself for the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of entering i.e., of joining into U.P. Judicial service online against Case Id : P00047752021 (old case id : 6934) and the same has already been processed before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Mirzapur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 29.04.2023. As such, there is delay in submitting the same from the part of the Officer. In this regard, the officer has stated in her online reply dated 29.08.2023, that (in her verbatim) *"I joined the Judicial service on 16.11.2019. I have sent the particulars of my movable and immovable property for the financial year 2019-2020 and 2020-21. Applicant is new in Judicial service and delay in this regard is highly regretted."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sushri Zeenat Parveen, Nyayadhikari, Gram Nyayalaya, Lalganj-Mirzapur, be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Mirzapur Judgeship for His Lordship's kind perusal and orders?
