May kindly see the property statement submitted online received from Sri Ramesh Singh, Presiding Officer, Motor Accident Claims Tribunal, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Gross income is Rs.56,85,496/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, PLI, Home loan and the balance of his savings bank account(s) is also enhanced for Rs.16,19,957/- this financial year from previous year's balance, toptal of which is Rs.42,78,879/-. Thus, a sum of Rs.14,06,617/- was therefore available with him to meet out the household expenditure of his family consisting three members in whole of the financial year.

It is pertinent to mention here that his son is self employed (Graduate/B.tech.) having annual income of Rs.2,40,000/- approx.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Devendra Pratap Singh, the then Administrative Judge, Bulandshahar. Property statements of the financial years 2010-11 to 2013-14 be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal & orders (in the misc. file of the officer) and statement of 2014-15, 2015-16, 2016-17 & 2017-18 has been submitted online on Application-IDs 46, 66, 134 and 151 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statement for the financial years 2018-20 vide online dated 23.12.2021. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ramesh Singh, Presiding Officer, Motor Accident Claims Tribunal, Sultanpur be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
