In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.34,47,441/-(Rs.34,18,919/- from salay and Rs.28,522/- encashment of NSC) and total deductions/ repayment/savings/ investment against GIS, NPS, Income Tax, PPF, Loan Repayments and Insurences are Rs.14,95,424/- and the balance of her savings bank account is also increased by Rs.46,162/- in this financial year from previous year's balance, total of which is Rs.15,41,586/-. Thus, a sum of Rs.19,05,855/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that the Officer's husband is a Judicial Officer whose annual income is Rs.15,13,689/- and Rs.16,81,386/- in the financial year 2019-2020 & 2020-2021 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held upto the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id: P00001302020 (old case id: 707) and the same has been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Mirzapur judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 23.12.2021. As such, there is no delay in submitting the same.
