May kindly see the property statement online received from Sri Indra Jeet Singh-II, Additional District & Sessions Judge, Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21(2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21(2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21(2019-20 & 2020-21), Gross income is Rs.32,34,685/- (income from salary is Rs.31,95,075/- and income from incashment of NSC Rs.39,610/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF, LIC and repayment of home loan, total of which is Rs.19,67,401/-. Thus, a sum of Rs.12,67,284/- was available with him to meet out the household expenditure of his family consisting of Six members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.2,31,655/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Mrs. Lovely Jaiswal is Civil Judge (Senior Division), Hapur having annual income of Rs.17,04,352/- and Rs.17,14,567/- in the financial year 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2017-2019 online and same has been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Mirzapur Judgeship on old case Id no.676.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21(2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21(2019-20 & 2020-21) vide online dated 23.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Sri Indra Jeet Singh-II, Additional District & Sessions Judge, Kannauj be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj for Her Lordship's kind perusal and orders?
