

## **Registrar (Judicial) (Budget)**

May kindly see the property statement submitted online received from Sri Pradeep Kumar Mishra, presently posted as Additional Principal Judge, Family Court, Agra regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

**In the financial year 2015-17 (2015-16 & 2016-17)**, his Total income from salary is Rs. 20,51,998/- and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, Car Loan, Scooter Loan, Sukanya Samridhi Yojna and SBI MF is Rs. 8,72,364/-. Thus, a sum of Rs. 11,79,634/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 57,245/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2013-15 (2013-14 & 201-15) which is also processed online and laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for kind perusal and orders on e-service Id no. 7323.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 05.01.2022. As such, there is delay in submitting the same from the part of the officer for which he has humbly apologized and stated that he could not submit the movable and immovable property statements due to sudden Gastrointestinal problem and kidney stone pain and was on Earned Leave and further he explained that due to busyness in judicial works and transfer in various districts it could not be submitted within stipulated time. May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Pradeep Kumar Mishra, Additional Principal Judge, Family Court, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
