May kindly see the online application received from Smt. Shruti Verma, Addl. Civil Judge (Sr.Div.)/ACJM., Lakhimpur Kheri regarding submission of statements of movable and immovable properties for the financial years 2019-2021 (2019-20 and 2020-21) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-2021 (2019-20 and 2020-21) of the officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

**In the financial years 2019-2021 (2019-20 and 2020-21)**, her total gross income from salary is Rs.24,21,728/- and total deductions/savings/investments/repayment against Income Tax, PPF, GIS, Car Loan,SIP and the balance of her Savings Bank Accounts is enhanced by Rs.4,66,422/- this financial year from previous year's balance, total of which is Rs.17,01,628/-. Thus, a sum of Rs.7,20,100/- was therefore available with her to meet out the household expenditure consisting of 4 members in the financial years 2019-2021 (2019-20 and 2020-21).

It is pertinent to mention here that Shri Praveen Ranjan who is the husband of the officer is in business with annual income of Rs. 6-7 lacs.

In this connection it is submitted that the officer has already submitted her property statements for the financial years 2017-2019 online against Case Id : P00001172021 (Old Case Id : 2091) which has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kanpur Nagar Judgeship.

The movable and immovable property statements for the financial years 2019-2021 (2019-20 and 2020-21) have been firstly submitted by the officer vide her online application dated 04.01.2022 which were due to be submitted upto the end of the financial year 2021-22 i.e. on or before 31.03.2022. As such, there is no delay in submission of property statement.

May, if approved, the statements of movable and immovable property for the financial years 2019-2021 (2019-20 and 2020-21) of Smt. Shruti Verma, Addl. Civil Judge (Sr.Div.)/ACJM., Lakhimpur Kheri may kindly be placed before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders.
