

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Anil Kumar-XI, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2015-17 (2015-16 & 2016-17), Gross income is Rs.19,04,328/- (from salary & arrears Rs.17,86,740 maturity of NSC & LIC money back Rs.1,17,588) and total deductions/savings/investment against GIS, Income Tax, PPF, LIC, mutual funds is Rs.11,65,569/-. Thus, a sum of Rs.7,38,759/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) is also reduced by Rs.38,578/- in this financial year from previous year's balance. It is pertinent to mention here that his wife is having annual income of Rs.1,60,000/- (approx) from business, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements for the financial years 2013-15 online and the same has been processed online against Case Id : P00051762021 before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. The officer has firstly submitted his movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) online vide his letter dated 24.12.21. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated (in his verbatim) that "due to mid-term transfer in year 2015 from Mainpuri to Outlying Court Nawabganj, District Bareilly and afterthat promotion in year 2017 in Senior Division cadre at Bareilly and in the year of 2019, annual transfer from Bareilly to Ballia and mid-term transfer in year 2019 from Ballia to Saharanpur, and from beginning year of 2020, long corona period and busy in judicial work as well as administrative work related to CJM Court and the having other Magistrate courts, I could not send my property statement timely. I apologize for such delay and humbly request to forgive the delay", as mentioned by the officer.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Anil Kumar-XI, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
