May kindly see the property statement submitted online received from Sri Arun Kumar Rai, Additional Principal Judge, Family Court, Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his Total income is Rs.38,28,284/- (income from salary is Rs.36,47,969/- & interest income is Rs.1,80,315/-) and total deductions/savings/investments against GIS, CPF, Income Tax, PPF, Insurances, and SIP (Mutual Fund) is Rs.28,30,667/- (including enhancement of Rs.14,72,403/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.9,97,617/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements for the financial years 2013-15 & 2017-19 online against case id 1899 & 1901 respectively and the same have been seen by Hon'ble Mr. Justice Alok Mathur, the then Administrative Judge, Bahraich judgship. And property statement of the financial years 2015-17 has also processed online on e-service Id no. 1900.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide his application dated 06.01.2022. As such, there is delay in submitting the same from the part of the officer for which he has mentioned in remark column that *"Due to non availability of some data submission of property statement is delayed . He begs his pardon."*

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Arun Kumar Rai, Additional Principal Judge, Family Court, Bahraich be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgship for His Lordship's kind perusal and order?
