

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Arvind Misra, Addl. District & Sessions Judge, Ghazipur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2014-2016 (2014-15 & 2015-16)**, the Gross income is Rs.27,18,256/- (Rs.25,12,791/- from Salary and Rs.2,05,465/- from matured RD) and total deductions/savings/investment against NPS, GIS, PPF, Insurances, Loan repayments and Income Tax is Rs.19,73,722/- and the balance of his savings bank account(s) is also increased by Rs.4,03,711/- in this financial year from previous year's balance, total of which is Rs.23,77,433/-. Thus, a sum of Rs.3,40,823/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2014-2016 (2014-15 & 2015-16).

It is pertinent to mention here that his wife have annual income of Rs.2,62,850/- & Rs.2,72,820/- as Doctor in the financial year 2014-15 & 2015-16 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-2014 (2012-13 & 2013-14) online against Case Id : P00052032021 (Old Case Id : 7382) and the same has been processed before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 01.01.2022. As such, there is delay in submitting the same from the part of the officer for which the officer has stated in his online reply dated 05.08.2024, that:

*“Reason for delay submission is that I forgot to file the property statement due to some family problem and health issues which are as follows-*

*Due to sudden demise of my father in July,2015 an emotional turmoil was faced by me & my family, especially, my mother. During that period, I had to visit frequently, almost on weekend, to my home district, Sitapur, to take care of my mother. Meanwhile, I had diagnosed with severe problem in my Prostate.*

*In August,2018, my wife suddenly faced life threatening situation for which she underwent a major surgery*

*In May/June 2019, my problem of Prostate worsened for which I underwent a major surgery at SGPGI, Lucknow in December, 2019. Meanwhile, in Feb,2020, my right ankle got fractured.*

*During COVID period, I had become Covid positive twice.*

*During COVID Lockdown, a serious problem started in my right hand wrist for which, I underwent a major surgery at Delhi in July,2021.*

*In above circumstances, it is my humble submission that delay was not deliberate and it is my assurance before the Hon'ble Court that I shall submit the property statement on time, in future.”*

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Sri Arvind Misra, Addl. District & Sessions Judge, Ghazipur, be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders?
