May kindly see the property statement submitted online dated 31.12.2021 received from Dr. Ajay Kumar-II, District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, gross income is Rs.51,49,740/- (income from salary including allowances & arrears is Rs.49,10,074/- and income from interest in MOD balance is Rs.2,39,666/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC Policy, Medical Insurance, SIP, PPF A/c, Housing Loan Repayment, Sukanya Samridhi Yojna and the balance of his savings bank account(s) is also enhanced for Rs.2,43,752/- this financial year from previous year's balance, total of which is Rs.38,32,215/-. Thus, a sum of Rs.13,17,523/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2016-18 which had already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Muzaffarnagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 31.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he stated that delay occurred due to covid-19 pandemic situations, the requisite bank statements as well as details could not be collected and in this period the undersigned was also transferred. The delay caused is deeply regretted and the same may kindly be condoned.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Dr. Ajay Kumar-II, District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
