May kindly see the property statement online received from Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2018-20 (2018-19 & 2019-20)**, his gross income from salary is Rs.34,19,116/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, Repayment of Personal Loan and Insurances are Rs.24,76,049/-. The balance of Rs.1,09,227/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,52,294/- (Rs.9,43,067/- from salary and Rs.1,09,227/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id-P00050792021 (old case id-7250) and same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 06.01.2022. As such, there is day delay in submitting the same. In this regard officer verbatim: " Respected Sir, the property statement for the Financial Year 2018-19 and FY 2019-20 was to be filed in appropriate time, but at the time of preparing details regarding property statement, mother of applicant was fallen ill and being the only son, applicant had to take care of his mother medication and careness. The applicant's mother died on June 14th, 2021. Due to the aforesaid reasons, there was a delay in filling the property statement of the applicant. Therefore, keeping the above facts in view, please forgive the delay in filling the property details"

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship Judgeship for His Lordship's kind perusal and orders?
